## What is this consultation about?

We would like to hear your views on the proposal to vary the current standardised school year.

## Introduction

The Standardised School is a set of principles used to determine school term and holiday dates.

Cheshire West and Chester Council is responsible for setting school term dates for Community and Voluntary Controlled schools across the Borough, but can only recommend them to Foundation, Free Schools, Voluntary Aided and Academy schools.

The proposal is to vary the current Standardised School Year model for Cheshire West and Chester's Community and Voluntary Controlled schools. The proposed variation is a result from requests from some schools who border neighbouring authorities and wish to be more aligned.

If Cheshire West and Chester Council agree to adopt the Standardised School Year model the intention is for it to be implemented in the 2024/25 academic year. By coming to this mutual agreement it is hoped it will encourage as many schools as possible within the borough, including Foundation, Voluntary Aided, Academy and Free Schools to adopt the pattern and therefore ensure greater consistency for families.

## Background

In 2012 Cheshire West and Chester Council previously consulted and adopted the current Standardised School Year, which aligned its school term dates with other Authorities in the Learn Together Partnership (LTP). This partnership consisted of Cheshire West and Chester Council, Cheshire East Council, Wirral Council, Liverpool City Council, Sefton Council, Knowsley Council, St Helen's Council, Warrington Borough Council and Halton Borough Council.

Following the disbanding of the LTP our neighbouring Councils have gradually moved away from this approach. Our term dates also differ from those of other neighbouring authorities, such as Flintshire, Wrexham and Shropshire who were not in the LTP.

Through feedback received we are only too aware how differing term dates can cause all sorts of problems for parents/carers, teachers and the wider community. Our neighbouring Authorities have moved to a holiday pattern similar to our proposal and it is hoped the proposal, if implemented, will help to avoid confusion, allow for transparency and consistency and bring alignment with term dates.

## Proposed variations

The table below, shows the current principles, alongside the proposed variations and their impact on the Standardised School Year.

## **Why vary the Current Standardised School Year?**

As previously stated, one consequence of the current pattern is that there can be marked variations in the length of terms and half term dates between Cheshire West and Chester schools and our neighboring Local Authorities. This can have a serious impact on some families who live, work and attend schools across our boundaries. Furthermore, schools who are able to set their own term dates within Cheshire West and Chester sometimes set their term dates to align with neighboring authorities, which can leave parents and carers within the Borough in difficult positions if they have children within different schools where term dates aren't aligned. This is not an ideal situation, which is further complicated if the parents work in school settings too.

Cheshire West and Chester Council's preliminary view is that the proposed approach is in the interests of children, parents/carers and staff and should;

- Align holidays for primary, secondary and special schools
- Provide a more even pattern of teaching and learning throughout the year
- Assist in improving patterns of attendance
- Improve consistency with schools in neighboring Authorities

- Provide greater consistency and improve work/life balance for children and their families and for school staff
- Improve school attendance, forward planning and holiday booking

## What happens Next?

All feedback received during the consultation period will be considered and used to formalise any variations to the standardised school year. A report will be submitted to Cabinet in July, detailing the outcomes of the consultation. Cabinet will consider the consultation outcomes and take a decision on whether to adopt the proposal. If the variations are adopted, the proposed implementation date will be Academic Year September 2024 and onwards.
